#### **RESOLUTION # 2025-11**

# A RESOLUTION APPROVING AND AUTHORIZING THE TRANSFER OF MONEY FROM GENERAL FUND TO TERMINATION BENEFITS FUND

WHEREAS, pursuant to Ohio Revised Code § 5705.13(B), the Board of Education of the Chardon Local School District (the "Board") has established a special revenue fund (Fund Number 035) (the "Termination Benefits Fund") for the purpose of accumulating resources for the payment of accumulated sick leave and vacation leave, and for payments in lieu of taking compensatory time off, upon the termination of employment or the retirement of employees of the Board; and

**WHEREAS,** pursuant to Ohio Revised Code § 5705.14(E), the Board may transfer money from the General Fund to any other fund of the Board; and

WHEREAS, the Board, in consultation with the Treasurer, has determined that it is in the best interests of the District to transfer One Million One Hundred Thousand Dollars (\$1,100,000) from the General Fund to the Termination Benefits Fund for the purpose of accumulating resources for the payment of accumulated sick leave and vacation leave, and for payments in lieu of taking compensatory time off, upon the termination of employment or the retirement of employees of the Board;

### **NOW, THEREFORE, BE IT RESOLVED** by the Board that:

Section 1. The Board hereby finds and determines that it is in the best interests of the District to transfer the amount of One Million One Hundred Thousand Dollars (\$1,100,000) from the General Fund

to the Termination Benefits Fund for the purpose of accumulating resources for the payment of accumulated sick leave and vacation leave, and for payments in lieu of taking compensatory time off, upon the termination of employment or the retirement of employees of the Board, pursuant to and in accordance with Ohio Revised Code §§ 5705.14(E) and 5705.13(B).

Onto Revised Code §§ $5/05.14(E)$ and $5/05.15(B)$ .
Section 2. Pursuant to Ohio Revised Code § 5705.14(E), the Treasurer is hereby authorized and directed to transfer the amount of One Million One Hundred Thousand Dollars (\$1,100,000) from the General Fund to the Termination Benefits Fund for the purpose of expenditures in accordance with this Resolution. Any additional transfer(s) from the General Fund to the Termination Benefits Fund shall require prior Board authorization.
Section 3. Pursuant to Ohio Revised Code § 5705.13(B), the Board may, by majority vote rescind the Termination Benefits Fund, and in such case, any and all money accumulated in the Termination Benefits Fund at the time of such rescission shall be transferred to the fund(s) from which they originated
Section 4. The Treasurer is hereby authorized and directed to take any and all other action as she may deem necessary or appropriate to effectuate the purposes of this Resolution.
Section 5. Any actions previously taken by District officials or agents of this Board in furtherance of the matters set forth in this Resolution are hereby approved, ratified and confirmed.
Section 6. It is hereby found and determined that all formal actions of this Board and any of its committees concerning and relating to the adoption of this Resolution were taken, and that all deliberations of the Board and any of its committees that resulted in those formal actions were held, in meetings open to the public in compliance with applicable laws.
Section 7. This Resolution shall be in full force and effect from and immediately upon it adoption.
